F. BUSINESS

1. Request #19-013 – Request for Traffic Calming Measures on E. 27th St (Justine Giacalone)

(Citizen states constant speeding, a need for traffic calming measures for the safety of the pedestrian traffic traveling to the schools in the vicinity. This item was previously heard at the November 12, 2019 Traffic Committee meeting.)

Citizen Justine Giacalone expressed her concerns with the traffic when children are walking to school. As directed at the last meeting, Committee Member OLMOS investigated the area, located the signage for the school and moved the signs to better locations for drivers to see. Committee Member DABNEY stated that he would add the area to his list to have more police presence during busy traffic times. Citizen Justine Giacalone wondered if putting in traffic speed sign with lights would be possible and stated she would inquire with school on that idea. Chairperson Designee CARDOSO suggested the possibility of future grants that would be able to provide funding for flashing overhead signage for the area.

MOTION: To deny the request for traffic calming measures, with staff looking

into the possibility of future grant funding for flashing signage or other

improvements.

2. Request #20-001 – Request for 4-Way Stop at the Intersection of V and 8th Street (Antonio Castaneda)

(Citizen requests installation of a 4-way stop at the intersection of V and 8^{th} Streets due to their concerns of vehicles speeding.)

Citizen Guillermina Prado expressed her concerns with children not being able to cross the intersection safely. Committee Member DABNEY detailed the accident history at the intersection and explained that it did not meet the necessary traffic warrants for the installation of a four-way stop. Committee Member OLMOS stated there are currently two crosswalks on V Street and Committee Member DABNEY affirmed that the Police Department actively works that area for speed. Chairperson Designee CARDOSO and Committee Member OLMOS explained to Ms. Prado that stop signs are not used as a traffic calming measure. Chairperson Designee CARDOSO asked Ms. Prado if she inquired with the school about additional crossing guards. Ms. Prado answered that she was told by the school they do not have the money for an extra crossing guard.

<u>Clerk's Note:</u> Committee Member OLMOS, as a designated interpreter as part of the City's Bilingual Assistance Program, interpreted Spanish for Ms. Prado.

MOTION: To deny the request for stop signs and request additional Police presence during school drop off and pick up times.

3. Request #20-002 – Request for a Painted Red/Blue Curb in Front of Concrete Pad on Citizens Property Located on Villa Dr. (Gloria L. Coronas)

(Citizen requests painting of curb red/blue adjacent to the concrete pad on their property due to neighbors blocking this area.)

Citizen George Jercich (speaking on behalf of Gloria L. Coronas), explained why he would like to have a red or blue painted curb in front of the property adjacent to their parking pad. Chairperson Designee CARDOSO asked Mr. Jercich how he gets to the parking pad since it lacks curb access. Mr. Jercich explained that he drives over the curb. Chairperson Designee CARDOSO informed Mr. Jercich that the entrance to the parking pad is non-compliant and that he must not drive over the City curb as this is against code and damages the curb.

Committee Member HREN explained that a blue handicap zone would have to be compliant with the Americans with Disability Act (ADA) requirements; including proper slope and curb cuts to allow a path of travel to the City sidewalk and that the Committee could not approve a blue curb without construction of the necessary improvements.

Mr. Jercich detailed ongoing neighbor disputes and explained the reason for needing the curb designation was due to his neighbor purposefully blocking access to the parking pad. Committee Member DABNEY stated he was familiar with the situation at this residence and explained that anyone can park in front of the parking pad since it is not a legal driveway. The Committee suggested Mr. Jercich work with the Building Department to make his driveway compliant, as this would then prevent anyone from blocking his access in the future.

MOTION: To deny the request.

Citizen Norma Cardona was not present. Committee Member OLMOS explained that G Street is an arterial street and that mid-block crossings on arterial streets are not recommended.

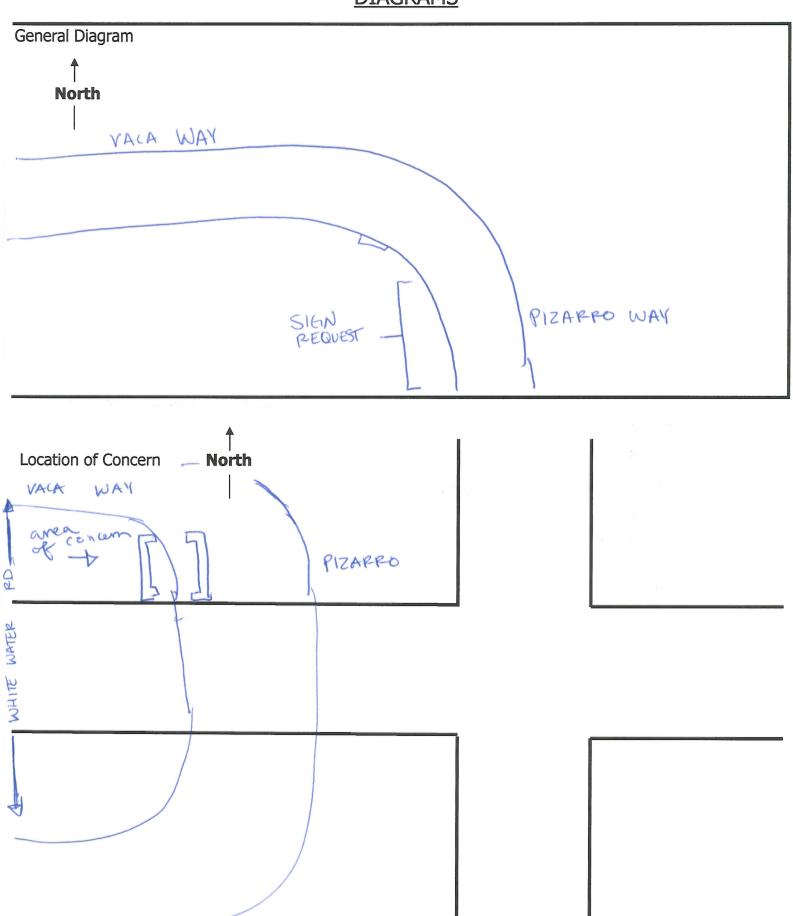

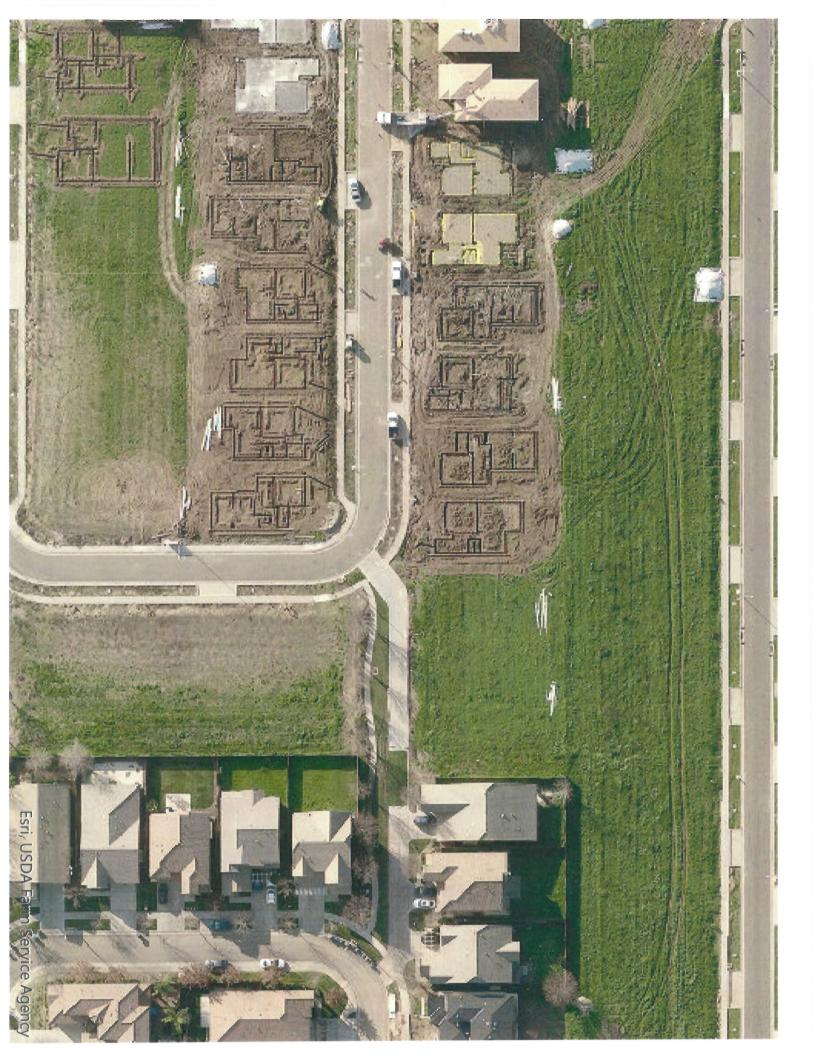
