5. Request #21-015 – Requesting Red Curb around entrance and Exit of Driveways at 2651 Cooper Ave. (Conrad Noriega)

(Citizen states parking on the street overnight near the driveways is too close for incoming and outgoing semi traffic.)

6. Request #21-016 – Requesting Handicap Accessible Curbs on the Corner of Parsons Ave. and Teak Ave. (Lisa Dalrymple)

(Citizen states it is a busy school intersection, needs handicap accessible curbs.)

Citizen Lisa Dalrymple discusses her concerns for the safety of people having access to the sidewalk without going into the street, no ramps or crosswalks available, and there are no speed limit signs.

Chairperson Beltran recommends working with Public Works to see what they can do to improve the areas safety measures. Merced Police department will check with the schools. They will discuss the speed limit sign on the next item.

Committee Member Olmos residential streets are not required to have speed limit signs due to the fact residential areas are 25-mph speed limit areas, he suggests more police enforcement in the area.

(Citizen states high speeds and reckless driving occur along Bancroft Drive and the crosswalks in the area are not protected.)

Committee Member Hren stated speed bumps are not recognized as a speed control device according to the US Department of Transportation Manual on Uniform Traffic Control devices (MUTCD).

Chairperson Beltran recommends looking into the signage in the area.

Committee Member Olmos recommends putting signage in the area to enhance visibility.

(Citizen states cars park in the area throughout the day, smoking pot, drinking, or engaging in other behavior, speeding and doing doughnuts, not allowing walking access to the path.)

Katlyn Mayo and Ann Rye stated their concerns with the increase of illicit activity, vehicular traffic, and safety issues at the end of the cul-de-sac going into the bike path area.

Committee Member Parker stated a permanent barrier is not acceptable due to the need of access to the bike path and the creek, possibly a moveable gate.

Chairperson Beltran stated Gating may cause more trash to be dumped in the area. Not in favor of blocking a city road. He would like to work with Public Works for different options to prevent the unwarranted vehicular traffic and illicit activity.

eliminating the undesirable traffic in the area.

(Citizens state there is no enforcement of the new speed limit, speeding/racing is still happening making it difficult to back out of driveways and cross the street to the community mailboxes. Regular flooding of the Rahilly Park bike path bridge causes pedestrians/cyclist to cross on the street.)

LuAnn Parson, Mayra Lopez, and Ronald Ringstrom stated their concerns on speeding traffic, over all safety in the area and lack of Police enforcement. They would like to see some of the safety items they have recommended implemented. The newly installed speed limit signs are not enough.

Committee Member Olmos agrees with the recommendation of adding additional speed limit signs midway in both directions to the area. He will check on the work order, to fix the issue of the flooding at the entrance of the bike path.

Chairperson Beltran stated putting Chicanes in becomes difficult monetarily due to limited funding. El Portal from Parson to McKee is considered a local road, and local roads in general do not have striping, but they can look into the cost of putting in striping through Engineering and Public Works or as a City project due to the size of that specific roadway. He will bring this item back to his staff additional ideas.

Committee Member Hren stated the implementation of the speed trailer in the area would help enforce the new speed limit would be a good solution, along with Police enforcement. He recommends researching putting in striping due to the uniqueness of the roadway in that area. Recommends keeping the signage limited, agrees to looking into other options.

MOTION: To take this item to the next Traffic Committee meeting and have the Engineering Dept. and Public Works dept. review the feasibility and

costs of striping and the possibility of putting it into the budget. Public works to put in additional speed limit signs and the Police dept. to place the speed trailer and increase Police enforcement.

I am responding to the request to have the City and County, who share responsibility for maintaining traffic flow on N Gardner Ave. to install speed bumps. Neighbors have signed a petition. Our petition (Sample Citizen Action Request Form for Neighborhood Traffic Calming) has been submitted to Our CountySupervisor who in tun has met with the appropriate departments of the City.

The speed of traffic traveling the street has exceeded 60 miles/hr on many days of every week and at different hours of the day and night. Walkers use the sidewalk and the extended street for morning and evening walks. At any given time on weekends, weekdays and especially in the evenings, motorists will do donuts at the corner of Destiny and Gardner. This is happening all to frequently. They are rasing in a ¼ mile strip. Teens have been obserbserved video taping drivers doing donuts and clocking the speed of racers







THE SPEEDING PROBLEM AS SEEN FROM MY YARD AT 1959 EL PORTAL DRIVE:

- Speeding on this street has always been a major problem. It got worse when the Moraga/Bright subdivisions were built. The college students living in these subdivisions and others consider, for some unknown reason, our street as a short cut to and from their McKee entrance (they only have two). It will get worst when the new nearby college apartments and those planned at McKee are completed. Others just drive fast with their cell phones to their ear!
- Some cars and motorcycles drive at approximately 50-55 mph through our curves. Most around 40 mph. Some enjoy dropping beer cans and fast food bags on our street. Worst traffic is morning & late afternoon into evening.
- Many times a car will pass another car or school bus. The worst passes are those that pass on the inside of a car (giving proper signals) turning into their own driveway!
- With the 18 new houses, the street now has many more young children on the street. This includes my two grandchildren. Also, many teenagers exit onto and ride across the street without stopping from the bike path!
- Walking across the street, one takes their life in their hands. You start to walk to the bike path entrance or to the mailbox and all of a sudden a car appears around a curve! 95% will not stop for you. They just drive around you!
- Backing out of a driveway, one often finds a car all-of-a-sudden coming around a broad curve (it wasn't there when you started backing out).

My past personal attempted solutions and future planned solution:

I have tried two solutions that did work! However, they did not last long! A third is being planned.

- 1 When my grandchildren visited I placed one of those 3ft tall flagged plastic kids holding a flag 4 feet into the street. The little kid has the word "SLOW" on it. It worked! However, I have had two stolen!
- 2 I once bought a portable flashing "SLOW" sign. I placed it on a saw horse on the unmaintained parkway strip across from my house..... at the Black Rascal Bike Path entrance. It is the best viewed street location. It worked! But I had to recharge those flashing lights nightly! Five days later it was stolen.
- 3 I am now going to try a third solution—a "SLOW" replacement sign on a tall permanent pole that says "SLOW & GEEZER CROSSING" with a picture of an adult with cane. (I walk with a cane 4x a day across the street to the bike path ...and 4x back). If I can get a good price for a solar outfit with flashing LED lights... all the better. This location can be seen from far away by cars traveling in both directions as the curves are broad.



Possible Good City solutions:

- believe there are two possible solutions that could be effective (B & C). More effective if combined.
- Narrow the street in spots with two or more chicanes (similar to Donna Ave between G & Wathen). (Putting that little plastic kid temporarily out onto the street seemed to work.)
- At the entrance/exit to the Black Rascal Bike Path, (which can be seen clearly in both directions) put up a sign to slow car traffic--"BIKE PATH X-ING" sign, with and added picture and "SLOW," perhaps use solar flashing lights. (That one at McKee and Silverstone sure works well, even without the lights flashing)
- D. There are many ideas outlined in the City's 2008 Traffic Calming Booklet that obviously will not work. I believe that one idea now used on another part of El Portal Drive (a double center line) will only give our curved street a better line for drivers to follow around the four curves.....kinda like Laguna Seca!

My name is Joe Brucia. Since 2007 I have lived at the exact middle of the four curved (two "S" curves) El Portal Drive between Parsons and McKee....1959 El Portal Dr. I am the former State President of CASCWA (California Association of Supervisors of Child Welfare & Attendance) and a district administrator for the Merced High School District. I have been involved in many, many safe-school inspections including facilities, walkways, parking lots and streets.

Marked with #1: Part of the Solstice Ave oriented W-E is the road used by many cars and motor-cycles that end up speeding up and down Pinnacle Dr. Until relatively recently, this part was just a dirt road and now it has an asphalt on it but it does not seem to be professionally turned into a regular street.

Residents from the Evening Star Dr. do not have to use the Solstice Avenue to get to the intersection of the Pacific and Horizons, which is the place one needs to use to get to and from the R street into this neighborhood.

Marked with #2. This part of the Solstice Ave. is, in addition, often used by motorcycles and even cars to get to the R street by using pedestrian path or green areas- there is no road for cars there. This path should be closed more appropriately. An additional reason for that is that cars speeding on the northbound part of the R street usually this path to continue speeding throughout the neighborhood, especially using the south-bound part of the Solstice Ave which is long.

The Pinnacle Dr is, in addition, the only driveway that connects directly the N-S part of the Solstice and the Horizons Ave and leads to the above-mentioned Pacific and Horizons exit from the neighborhood. It is obvious that the traffic flow in the direction opposite to the one I am describing has the same problems and essentially doubles the dangers to life and property on the Pinnacle Dr.

In order to protect lives and property on Pinnacle Dr, it would seem appropriate to pay a special attention to it, as it has special connections to streets that bring law-breaking cars. This is not to say that the rest of the neighborhood should be excluded from an effort to reduce number of speeding cars and motorcycles, etc. On the contrary, the entire system of the streets should be included in this effort.

I have taken a bit of time to examine some expert literature on issues we face here and "traffic calming" concept seems to describe what we need. It is broader than just issue mentioned. A Canadian National Collaborating Centre for Healthy Public Policy (http://www.ncchpp.ca/) shows some excellent research on effects of the traffic calming on number and severity of collisions, air quality, environmental noise, and other means of transportation. All of these are extremely relevant to the City of Merced as well. Our air is very polluted, partially because of the cars, noise levels that speeding cars bring into otherwise quiet areas of the city are extremely high, and Merced has a lot of children, pets, and wildlife all of which are impacted by all of the mentioned factors. In addition, the UC Merced brought in young people and people who need peace to study or do research. The Merced Community College is close as well. All of this is also stated as desirable goal for the US cities by the U. S. Department of Transportation (www.transportation.gov).

I will add here two figures copied from the Canadian source above, to make a point about speeding cars and deaths of pedestrians who are adult humans. For children and pets, disabled people, etc, the situation is even worse.




Figure 5 Narrowing of field of vision as speed increases




Figure 6 Probability that a pedestrian will die as a result of a collision with a car in relation to the speed at impact

The Figure 6 shows the reality (regardless of the law) of relationship between car speed and deaths of pedestrians. The speeds are in kilometers per hour but here is the translation into mph: 10 km/h = 6.2 mph; 20 km/h = 12.4 mph; 30 is 18.6; 40 is 25 mph; 50 is 31 mph; 60 is 37 mph; 70 is 43.5 mph; 80 is 50 mph; 90 is 56 mph.

In the areas with a lot of children, elderly, pets, teenagers on skateboards, or those learning to ride a bike or to drive a car, cars need to go very slowly to avoid injuries. The point here is **not to take into consideration just the worse case scenarios**. We want to feel safe to learn and play, and work not just to stay alive!!! We also want our neighborhood to look good and lived in. There are, unfortunately, a lot of houses rented out BY people who do not care about any of our local issues. Many of them bought houses when those were overpriced and are now desperate for money to keep them and this brings additional vulnerabilities to the area.

Everything mentioned above constitutes the request outlined below, for the Pinnacle Dr, as well as for the surrounding streets. I spoke with many neighbors and they feel the same way and may confirm the speeding cars problems, including grusome accidents and nearly-accidents caused by speeding cars and related issues described.

It seem obvious that some measures from the traffic calming suggestions are in place, but we would like to see more:

- 1. Bike lanes on both sides of the Pinnacle Dr. and both Twilight and Solstice Avenue as those are adjacent to the Pinnacle Dr.
- 2. A maximum number of Stop signs and visible crosswalks on every intersection along the Pinnacle Dr. (everybody needs to stop at those intersections. The Pinnacle Dr is the first street available to turn into when driving north from the Pacific via the Horizons. (tagged with #3 on the map). Recently, likely because of the position of our street (along with other people factors) we had a situation where the MPD pulled over a car that stopped on our street. (see attached photos below) The driver was very angry and asking "why did you pull me over?" while the response was "relax, I just have some documents for you". It is not clear that the Police had a legitimate reason to stop these guys and the whole thing escalated, within a minute, into the police officer holding a gun pointed to 4 very young people and the entire street was filled with about ten police cars and tens of officers. Several years ago, we also have had a situation where Sheriff's deputies were waiting for someone at the Solstice Ave. This person, sped from the Horizons, along the Pinnacle and turned to Solstice. I was working in my front yard and saw him. Seconds after I entered my house to drink some water, tens to hundreds of gunshots were fired from basically in front of my house. The said deputies were chasing the same car I saw before and shooting at it. The car went (as per reports) towards the passage (marked #2) and drove directly to the R street (eventually, speeding down the R it hit a house along the road and the driver was arrested). About several houses and cars on our street were hit by the bullets from the deputies. We have photos of the damage and several people were barely missed by bullets in their own houses. We and the MPD and the Sheriff's department are aware of these problems. Those scenes are deeply distressing even for adults, let alone children, and a major problem for residents here that pay their dues to live decent lives here. People are now avoiding involving these agencies in anything going on here. This brings more problems and the vicious spiral towards becoming an old and eventually ghetto - type area and city. Merced needs to consider these issues if it wants to keep its young and productive people that can prevent this from happening.
- 3. Street humps along Pinnacle Dr, Solstice and Twilight. These streets are long and secluded ideal for reckless speeders in cars or motorcycles.
- 4. Concrete containers with trees in the middle of Pinnacle Dr to serve as means to reducing "ideas" in drivers that the street is a race track. One such thing would be especially useful at the intersection Pinnacle and Solstice (marked #4).
- 5. Cameras and any other possible measures that non-expert citizen like me may not be aware of but may help with the situation.







Another result of speeding: a cat (possibly someone's property) killed by a high speed impact at a place where a kid could have been standing. I moved the dead cat (in rigor, with its eye popped out by the brain due to the force of impact) from the street and called the police. As it was a weekend, the animal control was not available and the MPD would not come-they told me to toss the cat in a trash myself, if it bothered me.

Would you like your toddler kids and grandkids see these scenes and hear all the noise, gunshots, and breathe all the dirt from excessive traffic and speeding cars on Pinnacle Dr. and similar areas?
