In the new version only annexation areas will provide for affordable housing. They also added in a pay in in lieu option, very low amount. The prior 10% requirement got reduced to 5%. There are other options too like land donation.

If landowners don't lower their prices this policy will severely restrict the ability to produce new housing in the City of Merced.
